Major terms and conditions governing extension of Provisional Recognition are:

- 1) The provisional recognition now granted is valid for 2011-2012 Academic year only.
- 2) All rules/regulations/conditions regarding admission of students, reservation of seats, etc. stipulated by the State Government and the University from time to time will be implemented/fulfilled by the institution, if so required.
- 3) All necessary infrastructural facilities will be provided by the management.
- 4) Prior approval of the University is mandatory for any change in the course(s)/intake.
- 5) The recognized institution should obtain renewal of recognition at the start of each academic year, after fulfilling all necessary preconditions therefore.
- 6) The Recognised Institution should rectify the defects, if any, pointed out by the Inspection Committee before seeking further extension.
- 7) Conduct of examinations and award of degrees will be done by the University.
- 8) The recognized institution should pay annual recognition fee as well as other fees as stipulated by the University from time to time.
- 9) The University reserves the right to visit the institutions at any time to satisfy itself of the compliance of the terms and conditions.
- 10) The shortage of faculty at higher levels may be filled up before the visit of the next Inspection Committee.
- 11) The college should take immediate steps to rectify defects/short comings pointed out by the Inspection Committee of the University, if any. (For this purpose a copy of the Inspection Report for the current year is attached herewith).
- 12) Non fulfilment of any condition will lead to withdrawal of recognition/non-renewal of recognition.
