Sanction is therefore accorded by the Vice-Chancellor to sanction extension of Provisional recognition of the Colleges and Courses as per the list appended for the Academic Year 2013-14 subject to remittance of necessary fees and reporting to the Syndicate.

Hence Orders are issued extending Provisional recognition to the Recognised Colleges and Courses as per the list appended subject to the payment of required fees due to the University on or before 30.05.2013 and following terms and conditions.

- 1. The provisional recognition now granted is valid for 2013-14, Academic Year only.
- 2. All rules/regulations/conditions regarding admission of students, reservation of seats, etc., stipulated by the State Government and the University from time to time will be implemented/fulfilled by the institution, if so required.
- 3. It is mandatory for the college to depute eligible faculty members for valuation duties in the University, as and when called for by the University.
- 4. All necessary infrastructural facilities will be provided by the management.
- 5. Prior approval of the university is mandatory for any change in the course (s)/intake.
- 6. The recognized institution should obtain renewal of recognition at the start of each Academic Year, after fulfilling all necessary preconditions therefore.



- 7. The Recognized Institution should rectify the defects, it any, pointed out by the inspection Committee before seeking further extension.
- 8. Conduct of examinations and award of degrees will be done by the University.
- 9. The recognized institution should pay annual recognition fee as well as other fees as stipulated by the University from time to time.
- 10. The University reserves the right to visit the institutions at a time to satisfy itself of the compliance of the terms and conditions.
- 11. The shortage of faculty at higher levels may be filled up before the visit of the next Inspection Committee.
- 12. The College should take immediate steps to rectify defects/short coming pointed out by the Inspection Committee.
- 13. Non-fulfilment of any condition will lead to withdrawal or recognition/non-renewal of recognition.
